

2011 WNBFB PRO MEN'S MASTERS Cup

DATE: Saturday, October 22, 2011 SITE: Poughkeepsie High School, Poughkeepsie, NY

ELIGIBILITY: This is an INVITATION-ONLY COMPETITION; athletes can only compete if invited by the WNBFB. All athletes must hold an active WNBFB Pro Card (\$75). Athletes must not have used any anabolic steroids, diuretics or prescription drugs or other banned substances for athletic purposes for a minimum of SEVEN (7) YEARS prior to the date of this event, and may not possess muscle implants. Failure to sign any liability, drug-testing or any other release form or waiver associated with this event, failure to pay necessary fees, or testing positive in either exam, will result in the forfeiture of the right to participate or receive prize money and loss of WNBFB eligibility. **All competitors must be age 40 or over to be eligible for the Pro Masters Cup! Proof of age is required with entry form.**

TESTING: All athletes will be polygraph and urine tested to verify their (7) years natural status since October 22, 2004. Urine sample collection will be conducted with the polygraph tests in a room to be announced. Polygraph testing will be performed at a designated site by appointment. **Polygraph Fee: \$40 Payable on the day of the test in cash.**

GET YOUR ENTRY IN EARLY! When you mail in your entry, you may request a sample time based on your travel arrangements (for example, say "Friday morning" when requesting an appointment). You will be notified of exact times based on availability. **IT IS REQUIRED THAT YOU RETURN THE "PRO MEN'S MASTERS CUP CONTRACT" WHEN YOU MAIL IN YOUR ENTRY AND FEES.**

DAY OF SHOW SCHEDULE: Prejudging: 10am Sharp. Evening Showtime: 6pm Sharp.

MUSIC: Athletes are required to bring their own music. Music must be on a CD and cued.

MAXIMUM TIME ALLOWANCE: 90 seconds STRICTLY ENFORCED. A professional-quality 90-second CD recording is recommended. Depending on the show size, a limit may be made on the number of Men that will do posing routines at night show.

DIVISION: Master's Men Over 40 and Over 50.

CASH PRIZES: () Master's MEN Over 40: 1st - \$2500, 2nd - \$1000, 3rd - \$500. Medal's 1st thru 5th place.

() Master's Men Over 50: Overall Winner - \$500. Medal's 1st thru 3rd place.

The Promoter reserves the right to split into classes based on participation.

I understand that I am responsible to attend the Prejudging and Night Show of the competition, and participate in all scheduled mandatory drug-testing that is required for my participation in the WNBFF Pro Master's Men Cup. I am also responsible to attend any publicity functions (photo shoots, interviews, media meetings, seminars, etc.) deemed necessary by the WNBFF to promote the competition. If I fail to attend any mandated activities, I will forfeit my entry fees and will be suspended from membership and participation in WNBFF events for a period of two (2) years from the contest date, plus I will be forced to requalify for the WNBFF from the INBF amateur ranks after the suspension time is served, should I wish to rejoin the WNBFF. I agree not to do any promotions nor make any appearances for companies, organizations or media outlets (print, TV or radio) that are not associated with the WNBFF or Wnbff Tournament of Champions. Any unauthorized appearance will result in my removal from the competition and suspension from WNBFF membership for two (2) years. If I have any questions on this matter, I will contact the WNBFF Vice-President to seek permission for such appearances, which may or may not be granted. I also agree to give my full cooperation and release all rights with regards to the videotaping or filming of the following: Worldwide television broadcast for Naturally Fit TV show and home sale rights of the WNBFF Pro Tournament of Champions Home Video, or any other authorized videotape or TV programming. Further, I agree to give my full cooperation and release all rights with regards to the photography and editorial coverage of the WNBFF Pro Tournament of Champions contest for use in Natural Bodybuilding & Fitness magazine and any other publications authorized by the WNBFF. Failure to cooperate will result in a suspension from the WNBFF. If, after returning this Contest Contract, I fail to compete for any reason other than a medical problem or emergency, for which I must submit verifiable proof from my personal physician to the WNBFF, I will be suspended from membership and competition within the WNBFF for two (2) years from the contest date.
